1. Which are our Services?

- d) Materials analysis;

- f) Artwork dry-cleaning;
- g) Educational cleaning courses;
- h) Teleconsulting.

2. Which are the purchasing methods?

The Formulas of each Service are gathered in four color categories according to the common purchase modality. All Formulas need the request of an estimate through the contact form, reachable through the dedicated section, and the buttons "Request a quote" and/or "Contact us".

2.1. Pink Formula

The email address communicated by the customer through the contact form to request the quote, will be used to agree a telephone interview for the definition of the same. Following the acceptance of the estimate, a contract of performance and privacy, and a first invoice will be sent. The invoice will require the payment of a down payment of 30% of the agreed fees. Subsequently, the service can be carried out on site in the manner agreed.

At the completion of the service, the payment of the balance of the second invoice will be required. Upon receipt of payment, the report will be prepared and sent to an address chosen and communicated by the client.

2.2. Orange Formula

The email address communicated by the customer through the contact form to request the quote, will be used to agree a telephone interview for the definition of the same. Following the acceptance of the estimate, a contract of performance and privacy, and a first invoice will be sent. The invoice will require the payment of a down payment of 30% of the agreed fees. Subsequently, the Indoor analysis service may be performed on site. Afterwards, the balance of the second invoice will be requested. Upon receipt of payment, the first report will be emailed. On a quarterly basis, a monitoring visit will be carried out at the same location and the respective Reports will be emailed. Upon completion of the monitoring cycle, a final Report will be prepared and sent to an address chosen and communicated by the Customer.

2.3. Green Formula

The Formulas highlighted in green include the following:

- Regarding the "Educational course for cleaning", the email address communicated by the Customer, will be used to communicate the rates (quote) and send the contract of performance and privacy. Following the acceptance of this, the invoice with the terms and timing of payment, will be issued. After the balance has been paid, the Service can be carried out on site in the pre-established procedures.
- Regarding the "Teleconsulting" Service, a preview of the questionnaire(s) will be attached to the email. The questionnaire will be submitted after the acceptance of the contractual conditions, and the receipt of the payment to be carried out within 30 days. For the Formula that includes also the video-consulting, a further correspondence will follow in order to agree the appointment.

For both Services a Report will be sent to the email address provided by the client.

2.4. Yellow Formula

The email address communicated by the customer through the contact form to request the quote, will be used to agree a telephone interview for the definition of the service procedures and communicate rates. Following the acceptance of the estimate, a contract of performance and privacy, and a first invoice will be sent. The invoice will require the payment of a down payment of 30% of the agreed fees.

At the end of each Service included in the carnet, the balance of the invoice issued for the single service will be requested. Upon receipt of payment, the report will be prepared and sent to an address chosen and communicated by the client.
